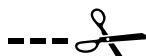

# **GIFT AID SWELLS BRANCH FUNDS!**

**Last year the branch received over £45 from the Inland Revenue as Gift Aid**

**Under the Inland Revenue's Gift Aid rules The British Beekeepers Association is a registered charity No. X49656 (212025) and are entitled to claim back from the Inland Revenue a sum of money equal to the tax that you paid on the income you used to pay this years membership**

## **HOWEVER**

You **MUST** pay income tax AND OR Capital Gains tax at least equal to the tax that the charity reclaims on your donations in the tax year (currently 28p for each £1 you give).

If in the future your circumstances change and you no longer pay tax on your income and or Capital Gains equal to the tax that the charity reclaims, you can cancel your Declaration by contacting the BBKA.

You can cancel this Declaration at any time by notifying the BBKA.

## **EVEN BETTER**

If you pay tax at the higher rate you can claim further tax relief in your Self Assessment Tax Return. If you are unsure whether your donations qualify for Gift Aid tax relief ask the charity, or ask your local Tax Office for Leaflet 1R65.
